TERMS AND CONDITIONS

These are the Terms and Conditions for the "This Little Red Dot..." Open Call ("Open Call") organised by the Singapore Art Museum ("SAM"), with support from Mapletree Investments Pte Ltd ("Programme Supporter"). By submitting your artwork, you agree to the following Terms and Conditions:

1 DURATION

The Open Call launches on **Wednesday, 30 April 2025, 8pm (SGT)** and closes on **Monday, 14 July 2025, 11.59pm (SGT)**. Late submissions will not be considered.

2 ELIGIBILITY

- 2.1 The Open Call is only open to individuals residing in Singapore with a valid Singapore residential address and non-employees of SAM. There is no age restriction.
- 2.2 Each participant may submit only one (1) artwork ("Artwork").
- 2.3 Only Artworks submitted by way of email to thistlittereddots@singaporeartmuseum.sg will be considered by SAM.
- 2.4 The Artwork submitted must be created using the template provided by SAM, ensuring the red dot and SAM's logo(s) remain in their original positions. The artwork should also stay within the designated rectangular box on the template. Submissions must be a two-dimensional illustration, scanned at a minimum resolution of 300 DPI. Artwork below this resolution may not qualify.

- 2.5 The Artwork must be the original work of the participant and created for the purpose of the Open Call. The Artwork must not infringe upon the intellectual property or other rights of any person or organisation nor violate any local and international laws and regulations.
- 2.6 All submitted artwork must be created solely by the artist. AI-generated work will not be accepted and may result in disqualification.

3 PARTICIPANT SELECTION, NOTIFICATION AND COLLECTION

- 3.1 Sixty (60) participants will be selected as the winners ("Winners").
- 3.2 The Winners will be announced and featured on SAM's social media page(s) by Friday, 15 August 2025 and each Winner will receive VivoCity e-vouchers worth S\$100.
- 3.3 For avoidance of doubt, all decisions made by SAM, including but not limited to the eligibility, disqualification and selection of all Artworks are subject to SAM's discretion, which shall be final and binding on all participants. No appeals will be entertained.
- 3.4 SAM will contact all sixty (60) Winners via email and/or telephone call. If the Winner does not respond within three (3) working days from date of receipt, SAM reserves the right to forfeit the prize and select another Winner. No compensation will be given for forfeited prizes.
- 3.5 SAM shall assume no responsibility and is not liable for any costs, charges or expenses that the Winner may incur in connection with the use of the vouchers or in order to receive the vouchers. SAM also shall not be liable for any loss, misdelivery or delay in the delivery of the vouchers.

4 USE OF PERSONAL DATA

- 4.1 By participating, participants agree that SAM may collect, use and disclose personal data that was voluntarily given to SAM for the purpose of contacting participants and administering the Open Call.
- 4.2 Photographs, videos and/or any other audio-visual recordings may be taken in relation to this Open Call. By participating, participants and/or their parents or legal guardians agree to grant SAM and its affiliates full rights to use the resulting images, audios or videos without any claims for payment or royalties. This may include (but is not limited to) use in any printed and online publicity, social media, and press releases.

5 OTHER INFORMATION

- 5.1 Participants hereby grant to SAM and the Programme Supporter the non-exclusive, non-sublicensable, royalty-free rights:
 - a. to use the submitted Artworks for future promotional, publicity or marketing purposes; and
 - b. to exhibit the submitted Artworks to the public at a selected venue, chosen at SAM's sole discretion;
 in each case, in connection with the Open Call and any future iterations or permutations of "This Little Red Dot..." Open Call, without notification to the Participants.
- 5.2 Participants undertake to release SAM, the Programme Supporter, staff, volunteers, partners or any other servants or agents from all liabilities, costs and claims for any injury, loss or damage, directly or indirectly caused by themselves or others, in the course of or as a result of participating in this Open Call.
- 5.3 Participants agree to fully indemnify SAM and the Programme Supporter against any liability, loss, damage, claim and cost (including legal costs on a full indemnity basis) incurred by SAM relating to or arising from use of the Artwork by SAM and/or any breach of the Terms and Conditions.
- 5.4 SAM reserves the right at its sole discretion to:
 - c. amend the shortlisted Winners announcement date and these Terms and Conditions at any time without prior notice; and/or

- 5.5 In the event of any disputes, these Terms and Conditions shall be governed by and construed in accordance with the laws of Singapore.
